You can walk into a DLPC office to take a written test, but you must make an appointment if possible. To get a permit in California, you need to apply in person at any of the Department of Motor Vehicles offices that offer drivers license services. You must have proof of identity and have completed the required application form, which is available online or can be downloaded from the Texas Department of Public Safety's website. If you're under 18, your parents or guardians will also need to fill out an application on behalf of you. If you're between 15½ - 17½ years old, you'll have to show proof that you finished driver education or are participating in an approved DE/DT program. Financial responsibility is required at all times while driving. Most Californians carry insurance cards as proof of coverage. Insurance companies provide these cards to policy holders. When parents sign for minors to get a DL, they agree to be financially responsible for them. If you're almost 18, do you need to complete DE/DT to get your instruction permit? Only if you are over 17½ but under 18 will you not have to take the DE/DT course. However, taking the driving test won't be possible until you reach 18 years old. If you completed DE/DT in another state and applying for a driver's license now, DMV may accept these certifications. To obtain a California driver's license, you must provide official documentation from your out-of-state secondary school that shows the completed courses are equivalent to a California course. You can get the required form, DL 33, from your local DMV office or by calling them at 1-800-777-0133. Send the completed form to your out-of-state school for processing. A provisional instruction permit is not considered proof of DE/DT, so you'll need to take a driving test within six months of applying for a license. If your application expires before that, you'll need to reapply and can use the time spent holding your previous permit as credit towards the requirement. You should bring both your expired and valid provisional instruction permits when taking the driving test, as proof of credit hours. Knowledge tests are available in-office during DMV business hours and must be taken before 4:30 p.m. Study the handbook and take practice tests to help you pass. If you have a valid driver's license from another country, you'll need to bring an accompanying person with you for the drive test.
