In-text citations basics An in-text citation is a brief reference within the text that points readers to the full reference at the end of the paper. You need one every time you quote or paraphrase someone else's ideas or words. A basic APA in-text citation consists of the author's last name and publication year (also known as the author-date system). If you're citing a specific part, include a locator like a page number or timestamp. For example: (Smith, 2020, p.170). There are two types of in-text citations: parenthetical and narrative. To properly cite sources in APA style, follow these steps: First, make sure you have all the necessary information about the source. If some details are missing, especially for online sources, adjust the reference accordingly. The basic components of an APA reference include author's name, publication date, title, and source. Additional information may be required depending on the type of source. For example, a book citation might look like this: (Author, Date). Title. Source. Date. If the source has no date, use "n.d." instead. For instance: (Author, n.d.). Title. Source. When creating an APA reference page, list all sources cited in your paper. The page should be double-spaced and have a hanging indent of ½ inch. Use a legible font like Times New Roman 12 or Arial 11. Include only sources that you've cited in the text, excluding personal communications that readers can't access. For instance: (Streefkerk, 2024) is an example of a citation for this article about APA referencing guidelines. There are several key differences in APA style that will be discussed in this guide. Sources are typically listed alphabetically by author's surname in an APA reference list, with sources indented from the second line onwards. For multiple citations by the same author, these should be listed chronologically by year of publication. Sources can be cited directly or indirectly: direct citations involve quoting verbatim, while indirect citations use a source to show that you have used an author's ideas. In APA referencing, there are two types of citation: in-text citations and reference lists. In-text citations contain a fraction of the full bibliographical information and should be rendered similarly to Harvard references. For sources with three or more authors, the reference section lists each author. When citing sources within the main body of the text, authors' names are joined with 'and', but an ampersand (&) is used in parentheses. Books can be cited using the following format: Last name, first initial. (Year). Title. Edition (if not the first edition of the book). Publisher. For books with three or more authors, only the first author's name should be listed in-text followed by 'et al.' and all authors should be listed in the reference list in the order they are credited in the original work. When citing chapters within larger books, it's crucial to include the page range (pp.) covered by that specific chapter. Additionally, when referencing individual chapters, ensure that the edition number is included in the citation unless it's the first edition. The citation format for a single chapter should be as follows: Last name, First initial. (Year). Chapter title. In: Book Title. Edition. Publisher. For instance: King, S. (2010). The best wines and where to find them. In: Loftus, E., ed., Fine Wine: A Guide, 1st ed. Nottingham: Delectable Publications, pp. 28-46. For citing multiple books by the same author, in-text citations can usually differentiate between works based on their publication year. The chronological order of publication should be observed, and if two works by the same author were published in the same year, they should be labelled with 'a', 'b', 'c' and so on directly after the year. The citation format for multiple books by the same author is as follows: Last name, First initial. (Year). Title. Edition (if not the first edition of the book). Publisher. For example: Brown, G. Delectable Publications. Tools for creating APA Book references provide guidance on how to format citations for books and chapters within those books. The rules for citing print journals are similar to those for books: if there are three or more authors, only the first author's name should be listed in-text followed by 'et al.', but all authors should be listed in the reference list in the order they are credited unless there are 20 or more authors. In-text citations for online journal articles remain the same as those for print articles, but the citation in the reference list has a few differences. Whenever possible, provide the Digital Object Identifier (DOI) of the source accessed. If no DOI is available, cite the URL of the article. Original sources should be properly cited in APA format by including author names, year of publication, article title, journal or newspaper name, volume and page numbers, DOI link, and URL. For journal articles, the citation includes both authors' names and URLs to accommodate different formats. Newspaper and magazine citations are similar but without DOIs. Website citations require identifying the author or source, providing a date, and giving an accurate URL. Social media citations include retrieval dates if content is likely to change and a set date for posts with specific dates. Image, film, video, and YouTube video citations also follow specific APA guidelines by listing director names, years of publication, titles, formats, countries of origin, or contributor usernames.
